

About The Humane Society of the United States

Some statements made recently at the Great Dane Club of the Mid South, Inc. meeting, and specifically by the Georgia Canine Coalition, are false and misleading. The work of The Humane Society of the United States is transparent and widely known. The facts are easily accessible:

**The HSUS is an animal protection organization**. The humane treatment of animals is a universal social value, and the vast majority of Americans want an end to cruelty and suffering. That is why one **out of every 28 Americans supports us**. The HSUS' mission is Confronting Cruelty and Celebrating Animals.

The Canine Coalition's statement that The HSUS supports the idea that companion animals "should be free, they should just roam" is preposterous – and should not be dignified. The HSUS has stood for more than fifty years as the nation's most important advocate for local humane societies and pets. In addition, The HSUS operates its own network of sanctuaries, making us one of the largest providers of animals care and sheltering in the United States. The HSUS provides no-cost veterinary care to dogs and cats in low-income communities around the world. In 2008, we provided more than 26,000 treatments valued at more than \$1.2 million in free services, and provided care for more than 70,000 animals.

The HSUS has published many books on pets, including "Dogs at Work," which encourages dog friendly workplaces. Many HSUS employees bring their dogs to the office, and others share their homes with cats, birds, rabbits and other pets. We wholeheartedly encourage people to adopt pets from shelters and rescue groups, and promote the benefits of pet keeping for animals and people alike.

The HSUS supports responsible breeders in ways that are evident from our literature and our website, humanesociety.org. We oppose puppy mills, which are large commercial dog production facilities that churn out litter after litter of puppies for sale in pet stores and online – leaving breeding dogs caged for much of their lives with little or no human affection. It's slanderous to suggest we don't support service dogs. We recognize and honor the unique skills that dogs have to aide people with disabilities, to perform search and rescue, to serve alongside law enforcement and military personnel, and to sniff out contraband such as drugs and bombs. Service dogs perform nobly. We support these programs, particularly when rescue dogs are given a chance.

We denounce violence in any form. The very foundation of The HSUS' work is to protect animals from suffering and cruelty caused by human actions. Any tactic or strategy involving violence toward people undermines the core ethic we espouse. The HSUS has repeatedly and publicly criticized individuals who break the law in the name of supposedly protecting animals.

The HSUS works collaboratively with law enforcement agencies at the local, state and federal levels. An April 2009 letter from the U.S. Department of Homeland Security to the HSUS notes, "We greatly appreciate your partnership with us on many

# important initiatives, such as developing guidance for the incorporation of household pets and service animals into emergency planning at all levels of government."

The HSUS has no affiliation with PETA. Certainly PETA has helped raise awareness of animal protection issues in our culture, but our policies and strategies are very different. Our programs are funded through contributions from millions of Americans who support our work. We give grants to many other animal protection organizations, but we don't provide financial support to PETA.

Criticism of The HSUS comes from individuals and groups that oppose some of our efforts. I appreciate this opportunity to clarify my organization's policies and activities, and hope that we can work together to advance efforts for the welfare of animals in Georgia.

Specifically, The HSUS supported the passage of SB 16 in Georgia to stop dog fighting. Two arguments were raised by groups whose intention it was to weaken the bill. SB 16 did not prohibit legal hunting practices, according to hunters themselves. SB 16 also did not have any breed specific language.

Other animal welfare legislation was introduced in the Georgia Assembly in the 2009 session, but not passed. This legislation was supported by The HSUS and blocked by commercial breeders and radical hunting groups who opposed these efforts. I hope thatlegislators will support these efforts in future years.

The following Georgia bills were tracked by The HSUS this year and will come up again next session:

Legislation to protect pets and children from being poisoned by requiring that a bittering agent be added to antifreeze. HB 219

A bill that would allow courts to include pets in protective orders to protect the animal and human victims of domestic violence. HB 429

A bill to aid law enforcement in cracking down on cockfighting by making cockfighting and activities associated with it illegal. HB 109
